## Annual Release of Liability

**LIABILITY:** In consideration for the rights to participate in any California Cushman Club display or event, participants and spectators (by execution of this form) Release and Discharge The California Cushman Club, their officers, agents, directors, employees, workers, volunteers, representatives of and members at large from any and all known and unknown damages, injuries, losses, judgments and claims from any cause whatsoever that may be suffered by any entrant, spectator or passenger or his or her property. The scope of this release includes services contracted or volunteered, such as transportation of people and/or equipment, food services and emergency medical treatment.

I furthermore understand that all participants operating motorcycles or motor scooters must have a valid driver's license with a motorcycle endorsement as required in their home state.

Drivers of all motor vehicles (including "chase vehicles") must have a valid driver's license and proper insurance coverage meeting at least the minimum requirements of the Financial Responsibility laws of their home state.

Higher limits of liability are strongly suggested by the California Cushman Club. Failure to observe this practice could result in ejection from the gathering and a loss of any and all fees paid to attend the event, except for emergency causes.

**BEHAVIOR:** The California Cushman Club and its agents reserve the right to restrict participants and spectators to acceptable behavior during all activities. Unacceptable behavior includes but is not limited to: permitting unlicensed drivers to operate motor vehicles; failure to observe helmet laws; failure to wear proper safety equipment; consumption of alcoholic beverages prior to or during a ride; or for other reasons a participant's conduct are deemed objectionable by the Ride Host/Meet Coordinator and/or CCC Board will be cause for ejection of entrant and vehicle from the premise. This includes persons, things, printed matter or any act or item of poor character for which the Ride Host/Meet Coordinator and CCC Board considers objectionable.
